Our approach to meeting the Products & Services Outcome and Price & Value Outcome – Information for distributors of the Product.

1. Summary of our assessment

We have assessed that:

- Our Joint Borrower Sole Proprietor (JBSP) Mortgage product range continues to meet the needs, characteristics, and objectives of customers in the identified target market.
- The intended distribution strategy remains appropriate for the target market.
- The Product provides fair value to customers in the target market (i.e., the total benefits are proportionate to total costs).

2. Product characteristics & benefits

The products are designed to meet the needs of the target group, the need to secure finance on a Residential Property with financial support from a joint borrower (the joint borrower will not be a registered legal owner of the property). The product features and criteria are designed to support these needs.

- The products provide a variable or fixed rate of interest.
- Variable Rates are controlled by us, meaning that the rate may go up as well as down
- Interest is calculated on a daily basis
- Variable rates have a floor
- The product may offer an initial discount for a period of time, after any initial discount period, the product will revert to our Standard Variable Rate for the remaining term of the mortgage unless an alternative product is selected.
- The product may require the payment of a product fee on application or completion, and an Early Repayment Charge if the borrower redeems the mortgage during any initial discounted period. The product may allow repayment of a percentage of the capital balance annually without incurring Early Repayment Charges
- Manual underwriting with applications assessed on a case-by-case basis
- Dedicated underwriting support
- Available on new and existing homes subject to LTVs

• Availability for Residential House Purchase & Re-mortgage.

3. Target market assessment and distribution strategy

This target market assessment matrix segments the target customers for the Product, recognising their different needs to enable you to tailor the services you provide when you distribute the Product.

The Product is not designed for customers who:

- Require a shared ownership or self-build mortgage
- Wish to make overpayments exceeding the maximum allowance without payment of Early Repayment Charges
- Require a Loan to Value in excess of that which is available in the product range
- Are credit impaired borrowers
- Are purchasing a property to let
- Do not meet our lending or property criteria
- Do not meet our lending policy
- Are purchasing or remortgaging a property outside of England & Wales

4. Customers with characteristics of vulnerability

The Society categorises Vulnerabilities as shown below: -

Health – Health conditions or illnesses that affect ability to carry out day to day tasks; **Life Events** – Life events such as bereavement, job loss or relationship breakdown;

Resilience – Low ability to withstand financial or emotional shocks;

Capability – Low knowledge of financial matters or low confidence in managing money (financial capability). Low capability in other relevant areas such as literacy, or digital skills.

The Product is designed for the Joint Borrower Sole Proprietor market segment which is likely to include some customers with characteristics of vulnerability or who will experience vulnerability over time.

Both the Joint Borrower & the Proprietor could be less likely to have a comprehensive understanding of the implications of the JBSP mortgage. They may require additional advice and support to ensure they understand the information being presented to them and the implications of the arrangement they are entering into to reduce the risk of harm occurring.

Joint Borrower & Sole Proprietor customers may also include First Time Buyers, who by their nature would also be less likely to have a comprehensive understanding of the implications of both the JBSP mortgage, and also of entering into the financial commitment of a first mortgage.

Joint Borrower & Sole Proprietor could also result in the "reverse" JBSP mortgage to help children who want to support their parents and/or grandparents to remain in their own home. Parents supported by their children can provide housing security for older borrowers. Characteristics of vulnerability could include health, resilience, and capability in respect of the parent.

Joint Borrower & Sole Proprietor mortgage customers may also include borrowers who are retired, who by their nature may also be less likely to have a comprehensive understanding of the product and may have characteristics of vulnerability which could include health, resilience, and capability.

Joint Borrower & Sole Proprietor mortgage customers may also include borrowers whose mortgage term will extend past their defined national retirement age, which may lead to characteristics of vulnerability which could include health, resilience, and capability.

We considered the needs, characteristics, and objectives of customers with characteristics of vulnerability at all stages of the design process for this Product to ensure the Product meets their needs.

We have also tested the Product to assess whether it will meet the identified needs, characteristics, and objectives of the target market, including customers in the target market who have characteristics of vulnerability.

We have in place a framework to achieve good outcomes for vulnerable customers, which includes:-

- Education and training for our staff to ensure they have the appropriate skills and experience to recognise and respond to the needs of vulnerable customers
- Suitable customer service provision and communications
- Flexible policies, where appropriate, to support vulnerable members
- Monitoring to ensure we continue to meet and respond to the needs of customers with characteristics of vulnerability

Intermediaries should continue to comply with your obligations to ensure that you treat customers in vulnerable circumstances fairly.
